



City of Chicago Viaduct Improvement Projects

Scope of Work:

The Viaduct Improvement Program will address significant roadway, sidewalk, safety and utility deficiencies in 58 locations under rail viaducts in the City of Chicago. In some project locations, the roadway surface is substandard due to the diversion of water runoff from eroding viaduct abutment walls. This program will resurface, rehabilitate, and restore the roadway and sidewalk. The program will also include utility and drainage improvements associated with various viaduct locations. In some cases ADA-compliant ramps will be constructed.

The Chicago Department of Transportation will manage these projects and the construction work will be performed for CDOT under competitively bid contracts.

Benefits

The roadway/sidewalk/curb and gutter projects in the Viaduct Improvement Program will enhance safety and security for motorists and pedestrians, increase personal mobility, reduce congestion, and improve bus transit operations. Improvement of the transportation and utility infrastructure in these locations will enhance the quality of life within these communities as well as ensure community sustainability.

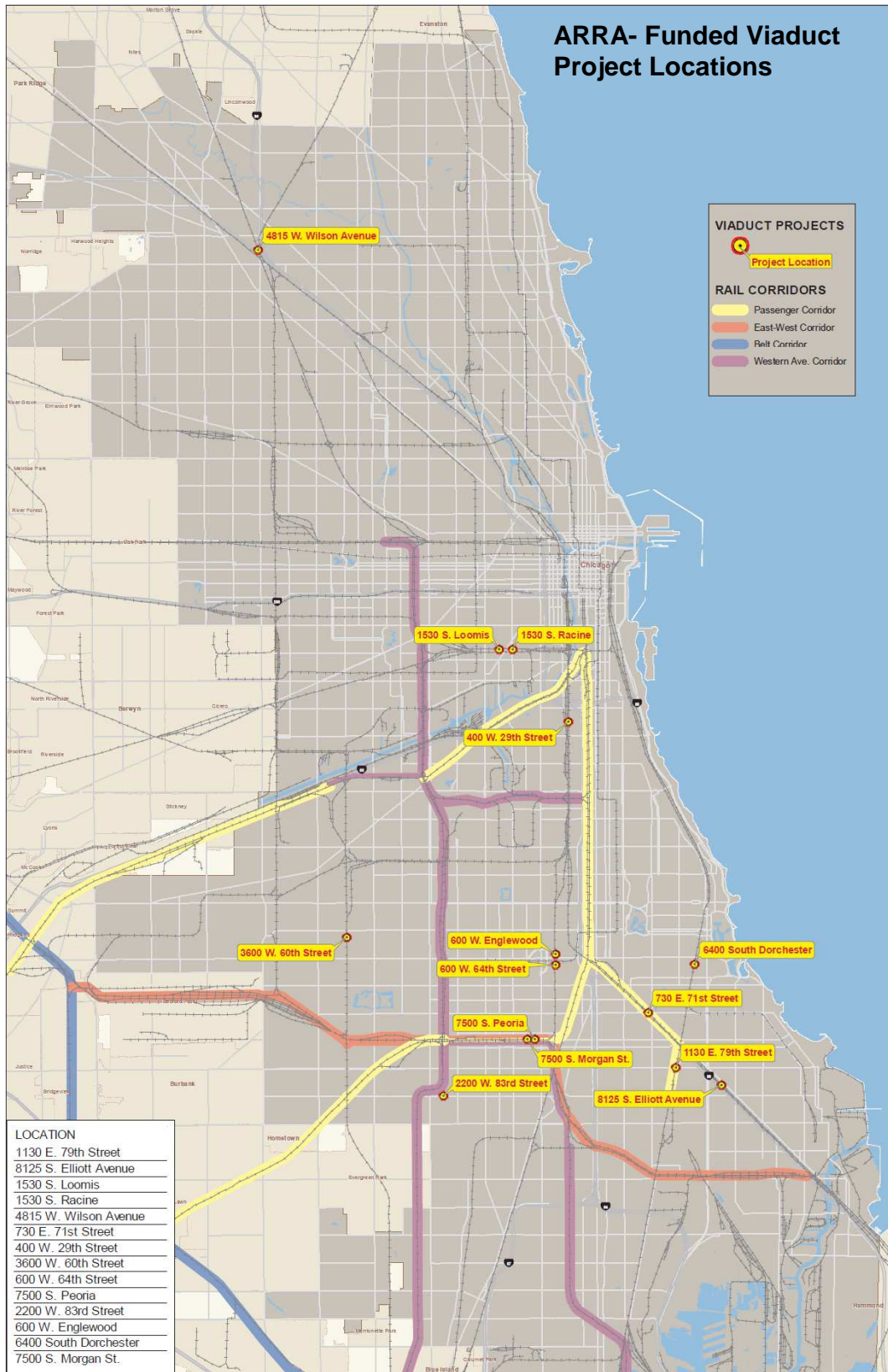
